



## **Arts & Crafts Competition**

Supreme Session 2010  
Competition Rules

1. Daughters submitting an entry or entries must be in good standing with JDI as of Sunday, August 1, 2010.
2. The article/item must have been made by the Daughter submitting the entry between the time period of August 2009 and July 2010, the Supreme council year.
3. All entries will be judged in two (2) groups by age and experience, as follows: 10-14 and 15-19 years.
4. All entries must describe the item in detail. The entry must be what is described. Substitutions will not be accepted.
5. All registrations must be postmarked by Wednesday, June 30, 2010. For a nominal fee a Certificate of Mailing may be obtained from the Post Office (in the USA, it is form 3617). The certificate will verify the date the registration was mailed. In the event that the registration gets lost in the mail, a copy of the Certificate of Mailing, and a copy of the registration will be accepted as proof the registration was mailed by the June 30, 2010 deadline. No registration forms will be accepted at the Session. If you wish acknowledgement of your registration, enclose a self-addressed, stamped envelope or email address with your registration form.
6. Judging will be Tuesday, August 3, 2010. When judging has been completed, the room will be open so entries can be viewed. **NO VIEWING WILL BE ALLOWED DURING JUDGING.** When judging is complete, the room will be open for viewing until 5:00 pm.
7. A Daughter may enter only one (1) article/item per category and no more than 9 (nine) total entries. A Daughter does not have to be in attendance to enter. If entries are being brought in by someone other than the Daughter, all items for a Daughter should be grouped together when checking items in.
8. Each Daughter must decide in which Division and Category she wishes her entry to be judged. However, in fairness to all Daughters, the Arts and Crafts Committee reserves the right to adjust categories.
9. All entries must be presented to the Arts and Crafts Committee by Monday, August 2, 2010 prior to 4:00 pm. in the room listed in the session program and newspaper. No entries will be accepted after 4:00 pm on August 2, 2010.
10. The decision of the Judges is final. A minimum number of points must be earned for placing in all categories.

11. Each Daughter must include a typed or printed 3" x 5" card attached to the entry containing the following information.

Note: Points are deducted if: 1) a card is not attached; 2) card not typed or printed clearly; or 3) card is missing any information.

1. All entries must be checked in AND out. The SGC, Arts and Crafts Committee and Judges will NOT be responsible for lost or damaged entries. Every precaution possible will be taken to guard against theft or damage.
2. Each Daughter entering the competition will be responsible for packing material. Packing material left in the competition room will be discarded.
3. The Committee plans to have all entries available for viewing on Wednesday, August 4, 2010 from 8:00 am until 5:00 pm.
4. Scrapbook entry forms MUST include the name of the person who will pick up the scrapbook – not just a Bethel number.
5. Entries must be checked out (claimed) by the Daughter on Friday, August 6, 2010 between 8:00 am and 4:00 pm. Any entry not picked up will be turned into Lost and Found.
